

# III PREMI NÈSTOR LUJÁN DE PERIODISME GASTRONÒMIC

III NÈSTOR LUJÁN AWARD FOR GASTRONOMIC JOURNALISM

## PARTICIPATION.

**All individuals, of any nationality and of legal age, who have authored a work of communication and dissemination of gastronomy and its cultural values in any format, including print, podcasts, radio, television, or any other medium, published or communicated for the first time during the year 2023, in any national or international communication medium, in Catalan, Spanish, French, or English, can participate in the III Nèstor Luján Award for Gastronomic Journalism, hereinafter referred to as "The Award."**

**No person who holds the status of Academic or has a relationship up to the second degree of kinship can compete for the award.**

## PRESENTATION.

**Entries for the Award can be submitted by either the author or the media that published or broadcasted the work, or upon recommendation by the Board of Directors of the same Academy, with the indication of the publication date and the medium. Entries can be in written, audiovisual, or digital format.**

**Entries must be submitted before 24:00 on March 18, 2024, by sending a color-scanned literal copy of the publication in PDF format via email to [acg@acgn.cat](mailto:acg@acgn.cat) or, if applicable, by transmitting an audiovisual copy through the same email.**

**Authors and media outlets can submit as many works as they deem appropriate, accompanied by a presentation containing the following information and commitments:**

- **Title of the work.**
- **Name and surname of the author.**
- **ID card or passport of the author, including a color copy of the document.**
- **Address of the submitter (author or editor).**
- **Email and contact phone number.**
- **Publication date and medium.**
- **An express statement confirming that it is an original work by the author.**
- **An express statement confirming that the work has not been submitted to any other contest or journalistic award previously.**
- **An express, unconditional, and irrevocable statement accepting all the current award rules.**
- **Date and digital or handwritten signature matching the ID card or passport.**

### **COMPOSITION AND OPERATION OF THE JURY.**

**The Jury will consist of nine members, five of whom will be Academics, and the remaining four will be renowned restaurateurs, journalists, writers, or editors freely designated by the Catalan Academy of Gastronomy and Nutrition.**

**The Jury will decide freely regarding the quality, interest, and gastronomic and journalistic value of the submitted works and will determine the Award winner, which may be declared void if necessary.**

**The Jury may decide to grant honorable mentions.**

**Each member of the Jury will have one vote.**

**The vote will be secret, and the final result will be definitive and unappealable.**

### **ANNOUNCEMENT OF THE WINNER.**

**The winner will be publicly announced alongside the National Gastronomy Awards during a gala dinner scheduled for June 13, 2024.**

**The Award will consist of a specially designed prize and will have a cash prize of 10.000 (ten thousand) euros.**

**In case of granting any honorable mention, the recipients will be publicly announced and recognized during the dinner, and they will receive a certificate.**

### **TRANSFER OF RIGHTS.**

**Participants irrevocably agree that, if awarded as winners or honored with any honorable mention, their work and image will be incorporated into the website or publications of the Catalan Academy of Gastronomy and Nutrition. Therefore, they unconditionally and irrevocably authorize, as broadly as applicable under the law, the text of their work and their image to be incorporated and disseminated through the mentioned communication media, which will in any case be non-commercial.**

### **JURISDICTION.**

**Participants accept, with the express waiver of any other jurisdiction that may correspond to them, that for any doubts, discrepancies, or claims that may arise regarding the interpretation of these rules, the parties will submit to the jurisdiction and competence of the Courts and Tribunals of the City of Barcelona.**
